### **QUESTIONS FROM MEMBERS OF THE PUBLIC NO. 1**

#### Under Procedure Rule No 10, Roger Lloyd, will ask the Portfolio Holder for Environmental Sustainability, Environment and Waste, Councillor D Foster, the following question:-

I live on the Anker Valley estate. The public open space on the estate is not adopted by the council and suffers from a number of problems resulting from this such as expensive management fees, poor service from the managing agent and poor build quality. Would the council agree that the private estate model is not working for Tamworth's residents and that the root cause of these problems is the lack of adoption by the council which has left these particular Tamworth council taxpayers at the mercy of greedy developers and agents? As such, would the council therefore consider adopting this estate, similar estates and future estates particularly given that the council is proposing to adopt Amington Green? Different treatment of taxpayers who pay full council tax but who are not receiving services ordinarily provided such as grass cutting or public waste bin emptying would be unfair.

### **QUESTIONS FROM MEMBERS OF THE PUBLIC NO. 2**

I live on the North side of Tamworth and have noted the Labour governments proposals to build 1.5m houses in 5 years and increase housing allocations each year. There are a number of new build developments being built and proposed on the North side of Tamworth as well as other areas (some of which fall under Lichfield or North Warwickshire council). What does the council propose to do in relation to relevant infrastructure delivery such as new roads, doctors and schools to ensure that existing residents quality of life is not diminished due to gridlock and difficulties getting doctors appointments?

Could you please explain how the council is paying tribute to Sarah and the entire Tamworth Castle team for achieving this fantastic milestone in Tamworth's History with what was once thought an impossible dream?

Additionally, how can we as members of the public support and capitalise on this significant milestone and the broader Tamworth heritage story?
