# MINUTES OF A MEETING OF THE HEALTH AND WELLBEING SCRUTINY COMMITTEE HELD ON 8th DECEMBER 2020

# 31 MINUTES OF THE PREVIOUS MEETING

The Minutes of the previous Health & Wellbeing Scrutiny Committee held on 20<sup>th</sup> October 2020 were approved as a true record.

#### 32 DECLARATIONS OF INTEREST

There were no declarations of interest.

#### 33 UPDATE FROM THE CHAIR

The Chair reported that Reset and Recovery meeting had been agreed by Cabinet at its meeting in October 2020, and that the membership included the Chair and another member of this Committee, Councillor S Peaple.

The Chair reminded members that he was aiming to form a working group on the Green Agenda, which he hoped would hold its first meeting before Christmas, and invited members to notify him of topics for inclusion.

# 34 SAFEGUARDING CHILDREN AND ADULTS AT RISK OF ABUSE AND NEGLECT

The Chair welcomed Councillor S Doyle, the Portfolio Holder for Regulatory and Community Safety, Ms J Sands, the Assistant Director, Partnerships and Ms S Ivey, the Partnership Vulnerability Officer to the meeting who were to provide the first of two biannual safeguarding updates to the Health and Wellbeing Scrutiny Committee.

Councillor Doyle introduced Ms Ivey who took the Committee through the Report and highlighted the following:

- The safeguarding service had continued to operate throughout the pandemic, and the Partnership Vulnerability Officer had been a point of contact, for staff, as well as statutory and voluntary sector colleagues who required support in relation to safeguarding and vulnerability within the community.
- 2. In terms of referrals made through the Council's reporting procedures, in addition to those set out in the report, since September 2020 there had been a further 8 referrals in respect of adults and 2 in respect of children.
- 3. It was confirmed that the planned amalgamation of the Stoke-On-Trent and Staffordshire Safeguarding Children Boards had not proceeded and they remained two separate boards. However, the Stoke-On-Trent and Staffordshire Adult Safeguarding Partnership Board remained a joint board. It was reported that the peer-to-peer audit workshop which had been planned had been deferred to the new year due to the pandemic.
- 4. In terms of safeguarding training, a significant amount of work had gone into the development of new online e-Learning modules, which were tailored to the Council's procedures and were expected to support staff and members in making referrals. Staff roles which required additional training, as well as for the Safeguarding Champions, were being identified and appropriate training would be sourced. Work was underway to review the delivery of taxi driver training in light of Statutory Taxi & Private Hire Vehicle Standards published by the Department for Transport July 2020.
- 5. The work of the Multi-Agency Child Exploitation Panel had been broadened and the partnership team worked with other agencies to identify children at risk of exploitation and to have robust processes in place around those identified children. The Tamworth Vulnerability Partnership continued to meet during the pandemic and continued to work to provide help at the earliest opportunity to improve outcomes for vulnerable people.
- 6. It was reported that the Suicide Prevention Procedure was aimed to support staff if they were dealing with a case where a person is threatening suicide and that consultation with staff was underway on its implementation.

The Assistant Director, Partnerships reported that further guidance had recently been issued on the PREVENT agenda which aimed to prevent and safeguard children from being radicalised. She reported that she would continue to work with the police on this agenda and also to review our procedures to ensure they

fully addressed the new guidance and would welcome the opportunity to bring this stream of work to the Committee in the new year.

The Committee thanked the Officers for their work and sought clarifications in the following areas:

- The overall picture in terms of vulnerability within Tamworth it was highlighted that reporting through the Council's procedures was only one element of the picture and that Staffordshire County Council were a further source. Any referrals made by schools in the Tamworth area would be made directly to county.
- 2. The potential for there to be significant unreported cases due to the pandemic, including lockdown periods and when schools were closed to most pupils unseen cases was a concern and a matter which was regularly review by strategic boards, and which had led to the campaigns to encourage communities to raise concerns with the local authority.
- 3. The role of safeguarding champions it was reported that these were designed to be a first point of contact where staff could discuss concerns they may have and could assist in referring onwards. It was also designed to ensure that each appropriate service area had a member of staff with additional expertise and training. Councillor Doyle confirmed that a similar safeguarding champion role had been established for councillors and Councillor M Bailey and himself were undertaking this role to promote awareness amongst members and to be available as a first point of contact. It was confirmed that the safeguarding champion role was intended to be in addition to the reporting procedures which existed including, where necessary, making direct referrals to Staffordshire County Council's First Response Service (regarding children), the Vulnerable Adult Service at Staffordshire County Council or to the Police.

The Officers and Councillor Doyle left the meeting.

**RESOLVED** that the Safeguarding Children and Adults at Risk of Abuse and Neglect be endorsed.

# 35 RESPONSES TO REPORTS OF THE HEALTH & WELLBEING SCRUTINY COMMITTEE

The Chair reported that he had attended Cabinet to provide observations on the Homelessness Strategy report including a suggestion to seek to minimise the use of acronyms and abbreviations to ensure that all reports were accessible. He further reported that Democratic Services had forwarded to all members a copy of the Council's Housing Solutions Rough Sleeping delivery plan which had been submitted to the Ministry of Housing, Communities and Local Government in November.

# 36 UPDATE ON HEALTH RELATED MATTERS CONSIDERED BY STAFFORDSHIRE COUNTY COUNCIL

The Chair invited County Councillor T Clements to provide an update to the Committee on the most recent Healthy Staffordshire Select Committee meeting held on 30<sup>th</sup> November 2020.

County Councillor Clements reported that this meeting had focussed on a presentation from West Midlands Ambulance Service in respect of Community First Responders. It was reported that some reconfiguration of the Community First Responders had been considered which would impact on their ability to use emergency blue lights, to administer drugs and to use liveried vehicles. County Councillor Clements reported that West Midlands Ambulance Service agreed that it would consult with the Community First Responders on the changes and that additionally County Councillors would also feed into that with the work undertaken in local areas by the Community First Responders.

County Councillor also reported that the Healthy Staffordshire Select Committee had looked at digital inclusion and exclusion and how to roll out the better broadband speeds across the county.

Councillor Faulkner asked whether County Councillor Clements could provide an update on the anticipated net effect of the proposals on the Adult Learning Disability Community Offer referenced in the Digest from the October Healthy Staffordshire Select Committee.

# 37 INTERIM UPDATE ON WORKING GROUP ON YOUNG PEOPLE

The Vice-Chair, Councillor P Brindley updated the Committee on the activities of and next steps for the Working Group on Young People comprising himself and Councillors S Peaple and M Greatorex.

He reported that the working group:

- 1. would focus on the 11-18 year old age group
- 2. had identified three issues on which to focus
- 3. had engaged with external stakeholders in the voluntary sector, Staffordshire Police and at Staffordshire County Council
- 4. aimed to present a report to the January committee meeting outlining the next steps.

The Chair reported that he had attended a meeting with the headteacher of Tamworth Enterprise College and discussed the possibility of inviting the headteacher to attend a future meeting of the Committee to discuss attainment.

# Healthy Staffordshire Select Committee – Monday 30 November 2020 District/Borough Digest

Under the Health Scrutiny Code of Joint Working with District and Borough Councils, Authorities have undertaken to keep relevant Partners informed of their consideration of health matters having regard to the general working principle of co-operation and the need to ensure a co-ordinated Staffordshire approach. Therefore, the following is a summary of the business transacted at the meeting of the Healthy Staffordshire Select Committee held on Monday 30 November 2020 - link to Agenda and reports pack:-

The Committee received a presentation/report from representatives of West Midlands Ambulance Service University NHS Foundation Trust updating them on the operation of the Community First Responders (CFR) Service in the County. This followed scrutiny of decisions taken by the Trust in April 2020 to make changes to the:- (i) vehicles used CFRs; (ii) range of drugs routinely carried by CFRs in their voluntary capacity and; (iii) training received, and county and county capacity capacity and county capacity and county capacity capacity capacity and county capacity ca					
The meeting was also attended by representatives of Staffordshire CRFs who outlined the impact of the changes from their perspective.					
Members heard that whilst 37 CFRs had resigned since implementation of the above-mentioned changes, further applications had been received from prospective participants, 97 of which had been shortlisted. The Trust re-affirmed their commitment to the scheme which they said would continue to be an integral part of their service to Staffordshire residents. In addition, they highlighted their performance against national key indicators which had been maintained notwithstanding the changes and additional pressures arising from the 2020 Covid-19 Pandemic. However, they sought assistance from Members in providing evidence where service standards had been compromised as a result of the changes.					
The representatives of the Trust went on to re-assure the Committee of their willingness to improve dialogue with all stakeholders (including CFRs) and that the operation of the Scheme would be kept under review so that any further changes found to be necessary would be made in the interests of improving patient care.					

# **Digital Inclusion/Exclusion**

The Committee also gave scrutiny to the work of the Cabinet Member for Finance and Resources in tackling digital exclusion and promoting digital inclusion to health services by residents in Staffordshire. The County Council had complied a digital Exclusion Action Plan containing practical measures to promote greater connectivity, accessibility, skills and communication for delivery during 2020/21 and 2021/22.

All Districts and Boroughs

Members highlighted the need for closer scrutiny of the various initiatives included in the draft Digital Exclusion Action Plan 2020/21 to ensure that they were fully aligned with the County Council's aims and objectives. They also drew attention to changes announced in the Government's Spending Review which might impact on the roll out of Broadband connectivity to those communities not currently served. The Committee recognised that connection speed and Broadband width were key to ensuring digital inclusion in the health and care. However, whilst both factors were not always within the County Council's control, wider digital infrastructure requirements had been included in the Plan for co-ordination with Partners, as necessary. Members also expressed concern about the level of intergenerational support available for residents who were not currently IT savvy, during the 2020 Covid-19 pandemic. They recognised the valuable contribution that the younger generation could make in sharing skills and knowledge and looked forward to time when schools could re-engage for the benefit of the wider community. These issues were acknowledged by Cabinet Member for Finance and Resources who reassured them of his commitment to the on-going development that Action Plan. In addition, an all Member virtual seminar would be held during the early part of 2021 in which they could contribute further having regard to their health remit. The Cabinet Member also spoke of the County Council's Participation in 'NHS X' which involved the trialling of mobile portals in residential care settings in order to support the digital transformation of care and reduction of social isolation.

Their next meeting will be held on Monday 1 February 2021 at 10.00 am, Virtual/on-line.
