1 APOLOGIES FOR ABSENCE

The Chair welcomed the new members of the Committee.

3 MINUTES OF THE PREVIOUS MEETING

The Minutes of the meeting held on 29th march 2022 were approved as a correct record.

4 DECLARATIONS OF INTEREST

There were no declarations of interest.

5 HOUSING STRATEGY UPDATE

The Chair proposed and the Committee supported the deferral of this item to the meeting scheduled for 12 July 2022 to facilitate the attendance by Officers.

6 UPDATE FROM THE CHAIR

The Chair shared with the Committee a draft letter from the Leader of the Council to the Midlands Partnership Foundation Trust (MPFT) regarding adult mental health services from the George Bryan Centre.

The Committee discussed the expected recommendations being made by MPFT to its Board which were expected to be considered at its upcoming Board meeting regarding inpatient services in south east Staffordshire for adults and the impact on the George Bryan Centre. The Committee supported the Chair drafting a letter, on its behalf, in support of the maintenance of inpatient adult mental health services from the George Bryan Centre. It was noted that during the consultation events attended by some members there had been significant support from those involved in the consultations to the continuation of inpatient services at the George Bryan Centre as well as the improvement in community services.

7 RESPONSES TO REPORTS OF THE HEALTH & WELLBEING SCRUTINY COMMITTEE

The Chair reported that at the 29 March 2022 meeting, the Committee had repeated their recommendation to Cabinet that it consider another location other than that of the Assembly Rooms for interim, front of house customer services as quickly as possible. This recommendation was presented to Cabinet at 9th April 2022 meeting where the Leader updated that he had authorised improved signage to the front of Marmion House to sign post to different routes to get in touch with the council including face to face. Further as part of the Reset & Recovery Programme update consideration by Cabinet at that meeting, authority was delegated to keep under review and where necessary agree revised customer service and reception arrangements.

The Committee considered that it was important to understand the perceptions of the public in terms of accessing the council face to face as well.

8 CONSIDERATION OF MATTERS REFERRED TO THE HEALTH & WELLBEING SCRUTINY COMMITTEE FROM CABINET OR COUNCIL

None at this time.

9 UPDATE ON HEALTH RELATED MATTERS CONSIDERED BY STAFFORDSHIRE COUNTY COUNCIL

The Committee had received as part of the agenda pack, three written update reports on matters discussed at the Staffordshire Health & Care Overview and Scrutiny Committee relating to meetings held on 15 March, 11 April and 30 May 2022. County Councillor T Jay highlighted that at the last meeting there was a focus on the metrics on waiting times for elective procedures and the focus in that area to improve these metrics. The main reasons for the long wait times were as a result of workforce pressures. It was further reported that Ambulance wait time was discussed and this would be considered further at a later meeting of the Staffordshire Committee.

Councillor D Maycock updated the Committee on the Healthier Communities workshop which had been organised by Staffordshire County Council which had taken place on 21 June 2022. Areas covered included the focus on health in every policy, how District and Borough Committees can input into the planning process and the role of the Local Plan and communications in terms of public health messaging, and the importance of partnership working with local charities and other organisations.

10 FORWARD PLAN

No further items were identified form the Forward Plan at this time.

11 HEALTH & WELLBEING SCRUTINY WORK PLAN - 2022/23

The Committee reviewed the existing work plan and the following areas were identified as possible areas of focus:

Health and Care Overview and Scrutiny Committee 30 May 2022

The Health and Care Overview and Scrutiny Committee considered the following matters:

Elective Recovery

Committee received a briefing containing actions that are being taken in respect of elective recovery and Adeavours to reduce waiting times for patients waiting for an elective procedure across the three acute Trust providers for the Staffordshire and Stoke-on-Trent ICS.

The Committee noted the progress update and asked that further information be provided about the theatre plan for University Hospital North Midlands (UHMN), the forecast for 104 week wait by specialism and the extent of digital consultation data available.

Changes to the Healthy Communities Services from April 2023

Committee considered proposals for the integrated lifestyle services, the contract for the Everyone Health specialist provider ends in March 2023. The contract includes weight management, physical activity, stop smoking, social isolation, falls prevention, and NHS health checks.

The Committee welcomed the increased focus on priority services, the focus on outcomes, the change to eligibility criteria, improved impact in communities and highlighted the importance of starting prevention early in schools.
