74 APOLOGIES FOR ABSENCE

75 MINUTES OF THE PREVIOUS MEETING

77 UPDATE FROM THE CHAIR

There was none.

78 RESPONSES TO REPORTS OF THE INFRASTRUCTURE SAFETY & GROWTH COMMITTEE

The Chair update the Committee that they attended Cabinet on the 1st February 2024 to present the recommendation made by the Committee on the 17th January, around ending plastic pollution, to look at the feasibility of a trial to strategically site some dual use bins around the town with ongoing

communications to explain and encourage the correct use This was approved. It was be diarised on the workplan to get an update on this.

They also attended Cabinet to share the three recommendations made by the Committee around the Future High Street Fund Project, after consideration of the recommendations it was agreed that a written response would be provided. Once this is received it would be shared with Members. It has been agreed that the Chair can attend the Board Meetings as a non-voting Member.

79 CONSIDERATION OF MATTERS REFERRED TO THE INFRASTRUCTURE SAFETY & GROWTH COMMITTEE FROM CABINET OR COUNCIL

There were none.

80 UPDATE ON FIRE SAFETY ACROSS COUNCIL ASSETS

The Chair introduced the report of the Assistant Director, Assets to provide an update on the Council's approach to fire safety across its assets. The Assistant Director was unable to attend but the Committee were asked if there any questions that they would like taking away for the Officers. The Chair had a question around the legal/risk implications but would contact the Officer about this.

RESOLVED that the Committee:

Note and endorsed the contents of the report.

81 LOCAL PLAN PROGRESSION OPTIONS

The Chair welcomed the Portfolio holder for Housing and Planning, Councillor S Smith, the Planning Policy and Delivery Team Leader, Richard Powell and the Planning Policy and Delivery Officer Laura Massey. The Portfolio Holder introduced the report to seek Committee endorsement of the recommendations to be made to Cabinet for approval for the revised approach to the delivery of a new local plan for Tamworth resulting from Government's proposed changes to the planning system, and for the publication of associated documents and highlighted the following before handing over to the Officers –

- ➤ The new system referred to in the report relates to the new rules in place for the local plan which is part of the Levelling Up and Regeneration Bill
- ➤ The current local plan was adopted in 2016 and covers the period up to March 2031.
- ➤ In 2018 the Government introduced legislation which requires all local plans to be reviewed every 5 years.

- ➤ In 2020 Tamworth Borough Council took a review of their local plan and determined that a new local plan was required.
- ➤ The current timelines stands as the 'issues and options' consultation was undertaken about a year ago. The 'preferred options' consultation would be due at the beginning of this year which will be discussed as part of the options.
- > The submission date for the draft local plan is currently at the end of 2025.
- ➤ The current transitional arrangements however require the submission to be by June 2025 with the plan being adopted by the end of December of 2026 so our current timeline, means our plan would be submitted after the submission deadline.

The Planning Policy Team Leader summarised the five option that were Identified in the plan noting that option 4, to update the existing plan now and do a new plan under the new system later, was the preferred option of the local Plan Working Group.

Upon further investigation Officers believed that this would require a similar amount of work as creating a new plan, and the updated plan would only have approximately six years left (National Policy states that new local plans should have at least 15 years to run at the point of adoption) and therefore that this was not the best option.

Option 5 was now considered the best option. This option was to get a new plan in place under the current arrangements by condensing the timetable by omitting a non-statutory stage of the process to submit the plan by the June 2025 deadline. Legal advice had been sought and this is not unlawful, however there was a small risk of challenge from the plan not being 'positively prepared' but that this unlikely. The Planning Inspectorate also advised that omitting the step would not be an issue as long as the Council is clear that they are not including this stage. It was highlighted that there was a possibility of the Government pushing back deadlines which may give them time for further consultation.

The Committee made the following comments/observations and asked the following questions:

- 1. What does the consultation period that is being omitted look like? The Officer confirmed that there are two statutory stages of consultation, the first stages is the 'issues and options' stage and outlines what the plan might include. The second stage is sharing of the draft plan. The stage which is being omitted is the 'preferred options' stage, where the Council's preferred approach is put out for consultation for 6 weeks for comments. However, due to limited available options, the Councils plan was already quite focussed at the 'issues and options' stage.
- 2. Are there any guidelines from the Government on expected timescales? It was confirmed that they are expecting more information over the course of the year but no specific dates.
- 3. Clarification over the resources table on Page 28 and noting that the reports states that the team has limited capacity, whether there was any plan in place if there were any resource issues?

Officers confirmed that this is the percentage of Officers time that is stated in the report is the time that it is expected that they would be working on the project. It is not 100% due to other commitments outside of the project. The limited resources referred to permanent staff and there is currently also a temporary member of staff in place until June 2025. It was also noted that by removing the preferred options part of the process this would help with workloads. There would also be consultants used to support the project where required.

- 4. Whether the cost of consultants had been worked out?
 The Officer highlighted that the report showed an estimate cost of approximately £375,000 for the project and that there £215,759 in reserve from previous years underspend, but that a policy change may be required for 2025/2026 to cover this.
- 5. Assuming Cabinet approval is given when would work start?
 Officers confirmed that they were already working on evidence gathering for the project.

RESOLVED that Committee endorsed the two following recommendations to Cabinet to :

- 1. Approve the revised approach to the development of the new local plan for Tamworth; and
- Approve the publication of the updated Local Development Scheme and Statement of Community Involvement.

The Committee agreed. The chair confirmed that they were expecting a Community Safety Partnership update, a CCTV update and the Dual Stream recycling Service Update.

It was highlighted to the Committee that the scoping form for the Bulky Waste item had been shared and that any comments could be emailed to add to the form with a view to this being added to the workplan.

It was requested that the Committee look at whether they could add any item to the workplan around Potholes and tress in the Borough and that representatives from County be invited on these issues. The Chair highlighted that Corporate Scrutiny had requested an update from Officers within the Council on trees within the Borough and that these could possibly be looked at together. It was agreed that a scoping document would be circulated for these items for more information before Officers were invited.

Background

The following Motion was submitted for consideration at Full Council on the 28th February 2023:

According to a map produced by The Rivers Trust using the latest available public data, there has been hundreds of hours of raw sewage discharge in Tamworth during 2021.

These discharges are across multiple sites in the borough, and we are sure that residents will be shocked to fund raw sewage is being dumped in local rivers in the 21st century. Residents should have access to clean rivers and open water and we very much support the steps the government is taking towards a 'polluter pays' principle when it comes to tackling river pollution.

It was resolved that Council

- Agreed to call on Severn Trent Water to undertake urgent action to prevent further raw sewage discharge into our local rivers in the short, medium and long term.
- ask scrutiny to look into this matter and engage with local partners, environmental bodies and utility providers to develop a broader approach to improving water quality in rivers in Tamworth; and
- 3. support the Government's new initiative to use money from fines for water pollution to benefit the nature environment and call for some of this to be used to improve Tamworth's environment. Letter to the relevant minister would seem appropriate?

Operations Service Performance Update and Data

Background

The purpose of this report is to provide the Committee with an update on Joint Waste Service Operations.

A breakdown of the Joint Waste Service (JWS) performance data is attached as Appendix A and the trends are discussed:

Operational Performance

Performance across the Joint Waste Service remains good. All collection rounds are being completed on time, with very few exceptions because of operational issue such as a breakdown or a road closure.

There was an average of 370 missed bins per month so far this year versus an average of 326 in the previous year. Since a record low figure in November, we have risen slightly, but constantly work to address.

An average of 2 complaints per month this year were received versus an average of 2.4 in the corresponding period the previous year.

The service has had a very good year in 2023 in terms of stats, so our challenge is to maintain the trends, finding improvements were possible.

Resident Participation

Resident participation in the recycling service remains very high with most properties presenting both a bin for the glass, cans and plastic and a bag for paper and card every fortnight. This presentation rate is between 98 and 99%.

In 2023 (calendar year), 44085 residents signed up to the Garden Waste Service. 35% of the total were Tamworth residents, with 65% being Lichfield residents. This is unsurprising due to the urban nature of Tamworth.

To date in 2024, 29000 residents have signed up for the Garden Waste scheme.

Residents now have the option to sign up to the Garden Waste Service using either direct debit or traditional card payment. This increases customer choice, and around 8% of residents have chosen direct debit as their preferred payment option.

The number of contaminated bins reported for the year so far as fallen to an average of 1279 per month versus an average of 1488 for the corresponding year. We did have a blip in January. We don't specifically know the full reason but have worked with the teams and February 2024 was our lowest figure to date at 967 contaminated bins. However, this may not be all positive, as is it reduced bins or our teams not reporting? The recycling officers and crews continue to work with residents to minimise this number.

The quality of the material produced by the JWS is high since the service change. Since the change to dual stream only 1 load has been rejected at the Materials Recycling centre. For Qtr. 3 23/24 contamination rates of DMR (Plastic, cans, and glass) was 2.89%, a slight decrease from 3.14% last quarter. Fibre was reported at 0% contamination.

Tonnage performance

The tonnage of both residual, organic and recycling waste is stable as indicated on the graphs in appendix 1.

Christmas saw the expected surge in recycling tonnage. In the two busiest weeks we averaged 164 tonnes of DMR and 252 tonnes of fibre per week. This is a 54% and 47% increase versus our average tonnage for DMR and fibre. It highlights the hard work of the team as the peak period passed without any major issues.

After the growth in residual waste tonnage over the Covid period, figures have settled down to an average 3128 tonnes per month so far, this financial year, versus 3051 tonnes in 22/23 and 3468 tonnes in 21/22. This is relevant as reducing residual tonnage is beneficial to all and is an action area.

The current recycling rate looks positive at 43.51% for the JWS, and 38.61% for TBC. However, this is only Q1 to Q3 figures and the % is likely to fall across Q4 as Garden Waste tonnage decreases through the winter months.

In the financial year so far, the JWS has collected an average of 1240 tonnes per month of dry recycling versus 1266 tonnes per month in the previous year. This follows a national trend of a steady decline in dry recycling and is an area which is being worked on.

Unfortunately, the trend across Staffordshire authorities is of recycling rates falling.

The current DRY recycling rate looks low at 21.09% for the JWS, and 21.41% for TBC. However, this is only Q1 to Q3 figures and the % will rise across Q4 due to expected lower Garden Waste tonnage.

The total tonnage of dry recyclate collected from the kerbside in 2022/23 has fallen 18% compared to 21/22. A total of 15,213 tonnes was collected in 2022/23 and 18,395 tonnes the previous year. The reduction is significant but does coincide with the country coming out of lockdown and we are now experiencing a cost-of-living crisis. There has also been a 10% reduction in residual tonnages over the same period.

A substantial residents engagement campaign will be launched before spring which aims to improve performance by explaining the benefits of recycling correctly, for both the community and the environment. It is being offered to all Staffordshire Authorities foc, and the aim is to licence the product to Councils around the country. Sponsorship from partners in the private sector has funded the campaign.

Financial Performance

Budget monitoring indicates the JWS is on track versus budget for 2023/24. At period 8 the anticipated outturn is a £40k overspend for the JWS, this is approximately £16k for TBC. This is against an expenditure of £9 million, with net expenditure of £3.3 million.

For comparison there was a £194,990 overspend on the Joint Waste Service budget in 2022/23. Whilst income levels were strong, there were significant increases in driver pay, agency rates, additional infrastructure on the Recycling Service and fuel. New property growth in both Tamworth and Lichfield has also had an impact on the budget. The overspend has been funded from the Joint Waste Service Reserve with Tamworth's share being £79,770.

Joint Waste Service Projects

Several important projects have completed, are currently underway or will be completed over the next few months. These include:

- Direct debits for Garden Waste subscriptions (COMPLETED)
- Completion of the migration of flats and HMOs onto the new dual stream recycling service (COMPLETED and being monitored)
- Options appraisal for the proposed mandatory weekly collection of food waste (high level appraisal completed – information to be shared with JWB). COMPLETED Intention is to arrange Member Group including LDC & TBC to review options (options may be limited due to Government policy).

- Fleet review and procurement (in progress tender out in April(?))
 - Cost increases will occur.
- Appraisal for moving fleet to alternative fuel (in progress)
- Launch of new recycling campaign (launch by Spring)
- Completion of the round review (to be revisited early 2024)
 - A number of rounds have been amalgamated, leading to a potential £50k saving per annum without an adverse effect on service level.
- Review of the commercial waste service

Purpose

To consider the 2024 annual refresh of the Tamworth Community Safety Partnership Plan 2023-2026, priorities, and action plan.

Recommendations

It is recommended that the Committee:

1. Endorse the 2024 annual refresh of the Community Safety plan and related actions.

Executive Summary

The Tamworth Community Safety Partnership Plan 2023-2026 is a three-year rolling plan which outlines how partners are going to collectively tackle community safety issues across Tamworth borough.

Cabinet endorsed the 3-year plan in 2023 and approved that the annual refresh and updated be considered by IS&G Scrutiny Committee for endorsement and publication, with the full plan (2023-26) only requiring further Cabinet endorsement if there are significant changes to the priorities. Attached as Appendix 1.

The IS&G Scrutiny Committee remain the agreed scrutiny under the Council's constitution for the Community Safety Partnership. This provides the opportunity for Scrutiny to continue to have more detailed oversight from Tamworth Police, the Assistant Director Partnerships, Portfolio Holder Environmental Health and Community Partnerships and the Staffordshire Commissioners Office on an agreed bi- annual basis.

The priorities set for 2023 were:

- Anti-Social Behaviour (ASB)
- Community Cohesion (including preventing radicalisation, exploitation and hate crime)
- Domestic Abuse (including stalking and harassment)
- Drug Related Crime and Harm (including the prevention of exploitation of young people – County Lines)
- Public Place and Serious Violence (including Violence, Abuse and Intimidation of Women and Girls -VAIWG)
- Vehicle Crime
- Vulnerable Persons (the prevention of harm to persons at risk of criminal exploitation or becoming victims of crime)

The 2024 refresh highlights what has been achieved against the outcomes set in the previous year and to outline priorities moving forward identified in the Community Safety Strategic assessment. There has been delay in the CSSA this year (commissioned by the Staffordshire Commissioner for Police Fire and Crime), however it is confirmed that priorities remain the same for 2024.

The local plans are supported and informed by the Staffordshire Community Safety Agreement 2023-2026 (Attached as Appendix 2)

Locality Deal Funding

The Staffordshire Commissioners Office (SCO) confirmed the Tamworth LDF allocation from April 20221 to March 2025 was £61,394 per year to support in order to:-

- support the development / commissioning of discreet schemes to address local priorities, as highlighted in the strategic assessment (using an updated agreed formula); and
- support the development / commissioning of joint initiatives to address shared priorities where this is appropriate / advantageous, as identified via the strategic assessment and the Strategic Community Safety Forum.

This allocation was made available throughout the current Commissioners term (3 years), as is reliant on the CSPs providing assurance over their capacity to manage the funding, submitting an outline spend to the Commissioner at the beginning of each financial year for sign off and a brief evaluation report at the end of each financial year.

In addition, £10,000 was made available for 2022/23 and 2023/24 to support more dynamic, local problem solving of antisocial behaviour (ASB) issues, with projects identified and agreed through local tasking processes.




ASB Control Chart

CASE STUDY

X has been well known to Police and Council officers for many years, with various attempts to resolve the issue through single agency interventions. The behaviour manifested itself with repeat calls, low level anti-social behaviour, theft, and abuse of the public and neighbours.

The case was discussed fully with a multi-agency meeting to take a problem solving approach. The Council took the lead in issuing Community Protection Notices and pursued prosecution. The Police then completed a requested for Criminal Behaviour Order on the back of a prosecution. The order has resulted in X being removed from Tamworth with appropriate support and the concerns resolved.

New Era Victim Service


The new contract arrangements for the New Era service commenced on 1st October 2023. Achievements of the last five-year period of the contract show 21,365 referrals and enquiries with 14807 individual supported in service. For Tamworth:

Supported Victims 1392 9% of all supported
Perpetrator Service 47 8% of all supported


During Q3 2023/4 (commencement of the new contract) 131 referrals were made for Tamworth (of which 24 were children) and 216 individuals are currently supported.

Demand for services pan-Staffordshire has increased and is expected to grow.

Police Reported Domestic Abuse



Overall, a 3% increase in last 12 months which is not considered significant. This is against relatively low levels (in the previous 12 months Tamworth was the only LPT to see a slight reduction in DV). Increase in reporting due to national and local campaigns raising awareness can be expected and encouraged to protect vulnerable victims.



The only statistical increases in Domestic violence are in red above.

Public order increase is 11% and likely to be a crime recording if officers are pursuing a victimless prosecution for example.

More serious violence increase is +88% which sounds concerning but this is due to new offence recording of non-fatal strangulation which fits in this category and used to be recorded as common assault (less serious violence).

For information, other violence (largest by volume) is predominantly stalking/harassment. There is a low threshold for recording these – only 2 incidents amount to a course of conduct.

CASE STUDY

Information around concerns about drug dealing were raised at residents' meetings and via local councillors which at the time had not been formally reported.

Working with PCSOs and housing teams requests were made to ensure that every concern was reported to obtain evidence for appropriate actions.

Subsequent work, evidence gathering and proactive use of enforcement has finally resulted in prosecution and eviction of family, giving wider reassurance to the community.




Occurrence Volume Chart

CASE STUDY – BETTER WAY RECOVERY

On 6th September 2023 they celebrated 1 year operating in Tamworth. They are now delivering 4 support groups over 3 days per week including an evening group every Thursday from 5pm - 8pm with a support group 6pm - 7.15pm, which will be held at Offa house.

There are now 5 peer mentor volunteers in Tamworth, and 2 more being DBS checked who have both got over 6 months abstinence since coming to Better Way.

The group continues to work extremely well with Staffordshire County Council addiction services to deliver the best wraparound service possible for people in Tamworth.

CASE STUDY - VULNERABLE PERSON

James, a 79 year old gentleman, came to the attention of the Tamworth Fire and Rescue Service Prevent team following a referral form the West Midlands Ambulance Service. This was due to him living in a small flat that was heavily cluttered and the occupier presented mobility issues claiming there was no smoke detection.

A Safe and Well Visit was conducted in the Home. The initial concerns regarding the clutter had been somewhat addressed by James's daughter however advice and tips were given to reduce trip hazards in the home along with Fire Safety. What became apparent during the visit was that James was scared and worried about using his appliances due to the increase cost in energy bills so was putting his health at risk by not eating hot meals nor heating his home appropriately this was also having an impact on his mental wellbeing.

Due to the Partnership links we have within Tamworth we made a referral to Communities together CIC, this is to see what support can be given and ensure he is receiving everything he is entitled to so he can heat his home and cook meals.

Referrals also made to Tele Care to provide James with a Falls Pendant alarm should he fall he is now able to press a button or the pendant will automatically call for help.

James is now receiving Support, able to heat his home and it was left with his daughter to get in touch if anything else further was needed.

Further activity is outlined in the Community Safety Plan work plan and annual refresh to include:

- Review of strategic thematic meetings
- Problem solving approach to Vulnerability Partnership/ASB Coordination Group
- COMF/UKSPF projects
- Partnership events programme
- SFRS Safe and Sound Week 9th-25th April 2024
- Continued work on priorities as outlined in this report

The updated work plan is attached as Appendix 3.

All work streams continue to have a robust work plan with a number of underlying principles to ensure that we embed our approach to delivery of the plan:-

- Prevention wherever possible
- Early intervention
- Targeting prolific offenders
- Targeting resources to hotspot areas
- Supporting victims
- Increasing public confidence

Through early intervention the CSP will prevent issues escalating, reducing harm to individuals, and ensuring that they receive help and support as early as possible.

The Community Safety Plan will be continue to be overseen by the Tamworth Partnership Coordination Group and scrutiny will remain with the Infrastructure Safety and Growth Committee.

Options Considered

None – a Community Safety Plan is a legal requirement to prevent crime and disorder.

- Supporting victims
- Increasing public confidence and perception

What is Tamworth Community Safety Partnership?

Tamworth Community Safety Partnership is a collection of statutory agencies working together to reduce crime and antisocial behaviour across the town.

The partnership goes further than this and includes a wide range of committed organisations, local charities, businesses, residents and community groups who work independently and together to make Tamworth a safer and stronger place.

This partnership is overseen by the Community Safety Partnership Board which is made up of the statutory partners:

- Tamworth Borough Council
- Tamworth Local Policing Team
- Staffordshire Fire & Rescue,
- Staffordshire County Council

- Staffordshire and Stoke on Trent Integrated Care Board
- Midland's Partnership Foundation Trust
- National Probation Service.

The Partnership is also supported through the collaborative work with commissioned and voluntary services including:

- Support Staffordshire
- Staffordshire Council for Voluntary Youth Services (SCVYS)
- New Era Domestic Abuse service
- Harmony ASB
- Uniting Staffordshire Against Crimes of Hate (USAH)
- Community Together CIC
- Heart of Tamworth
- Better Way Recovery
- Fun Club
- Beat the Cold
- Citizens Advice Mid Mercia
- Tamworth Street Angels
- Pathway

The wider role that the community and voluntary sector groups in Tamworth play in the delivery community safety outcomes is extremely important.

The main role of the partnership is to actively lead on the development and delivery of strategic approaches to a range of priority crime and community safety issues. The priorities for 2023-2026 are set out on the next page of this plan.

Delivery

The Community Safety Partnership Board will appoint theme leads from the partnership who will oversee delivery of work within that work area. Real-time data will be used to re-assess the proposed actions and report on the measures of success and ensure we can set achievable targets that make the required impact.

Theme leads will lead the collaboration and delivery of work in these areas and will report back to the Board on outcomes and performance.

An annual review and refresh will take place by the Tamworth Borough Council Infrastructure Safety and Growth Scrutiny Committee who will independently scrutinise the work of the partnership.

The Partnership continues to be funded through the Staffordshire Commissioner's Office (Police, Fire and Rescue, Crime) Locality Deal Fund. Commitment for 2023/24 and 2024/25 is £61, 394 per year.

The 2022 Tamworth Community Safety Strategic Assessment has identified the following areas as priority work areas for 2023-2026. These priorities remain the same for 2024.





1 Introduction

- 1.1 The Community Safety Agreement (CSA) outlines the key community safety priorities for Staffordshire. The CSA is reviewed and refreshed every three years.
- 1.2 The CSA is mandatory for two tier authorities such as Staffordshire and helps us to meet our statutory duty under Section 17 of the Crime and Disorder Act 1998 (as amended by the Police and Justice Act 2006) in which responsible authorities are required to consider crime and disorder in the delivery of all their duties.
- 1.3 Its membership reflects this with all statutorily required partners (including Staffordshire Police, Staffordshire Police and Crime Commissioners Office, Staffordshire County Council, Staffordshire District and Borough Councils, Fire & Rescue Authority, Probation and Health) represented, in addition to other agencies who contribute to developing stronger, safer, and more resilient communities.
- 1.4 This agreement aims to develop a more joined-up approach to public service delivery, to enable more effective and co-ordinated strategic planning across partner agencies and to ensure sustainable and lasting improvements in delivering outcomes. It recognises that community safety issues do not always respect district boundaries, and that coordination of effort can lead to economies of scale, joined up working, and more effective outcomes.

1.5 Whilst Stoke-on-Trent City Council does not form part of this agreement, it undertakes a similar process. Where appropriate Staffordshire County Council works with Stoke-on-Trent City Council to tackle common priorities.

2 Legislation

The following Chapter outlines the key pieces of legislation and statutory duties that direct the work of the Staffordshire Community Safety Partnership.

- 2.1 The Crime and Disorder Act 1998 gave statutory responsibility to local authorities, the police, and key partners to reduce crime and disorder in their communities. Under this legislation the responsible authorities, referred to as Community Safety Partnerships (CSPs), were required to carry out three yearly audits and to implement crime reduction strategies.
- 2.2 The Police Reform and Social Responsibility Act 2011 introduced directly elected Police and Crime Commissioners (PCCs) to replace Police Authorities in England and Wales. This brought a requirement for the PCC to have regard to the priorities of the responsible authorities making up the CSPs and for those authorities to have regard to the police and crime objectives set out in the Police and Crime Plan. The legislation also brought with it a mutual duty for the PCC and the responsible authorities to act in co-operation with each other in exercising their respective functions.
- 2.3 The requirement for Community Safety Partnerships (CSPs) to conduct Domestic Homicide Reviews (DHR) came into effect on 13th April 2011 as a result of the Domestic Violence, Crime and Victims Act (2004). The process is managed, coordinated centrally by the Staffordshire Community Safety Team on behalf of the District and Borough CSPs.
- 2.4 The Domestic Abuse Act 2021 received Royal Assent on 29th April 2021. The DA Commissioner has powers to compel public bodies to cooperate with her office and make recommendations for public bodies to respond to within 56 days.
- 2.5 Part 4 of the DA Act requires Tier 1 authorities to; create a Local Partnership Board with responsibility for conducting a needs assessment, complete a Domestic Abuse Strategy on safe accommodation and undertake commissioning activity in relation to accommodation-based services.
- 2.6 **Serious Violence** created a new duty on organisations to collaborate, where possible through existing partnership structures, to prevent and reduce serious violence. In addition, there was an intention to amend the Crime and Disorder Act 1998 to ensure serious violence is an explicit priority for Community Safety Partnerships, in recognition of the significant role of CSPs. The new duties have been progressed through Parliament as part of the 'Police, Crime, Sentencing and Courts Bill,' which received Royal Assent on 28th April 2022.
- 2.7 **Fire Safety: The Fire Safety Act 2021** received Royal Assent on 29th April 2021. The Act was introduced to clarify who is responsible for managing and reducing fire risks in different parts of multi-occupational residential buildings to prevent future tragedies, such as the Grenfell Tower. In addition, the Government is also looking to introduce a Building Safety Bill which would give

residents and homeowners more rights, powers, and protections – making homes across the country safer.

Key Changes to the Community Safety Landscape

- 3.1 Coronavirus (COVID-19) pandemic has had an unprecedented global and local impact. While restrictions have been lifted for some time now, a vaccine has been deployed, and both transmission and severity of Covid have reduced, the country is in a stage of recovery and the impact of the pandemic is still being felt. The pandemic has changed the way that partners are able to deliver services, with the working practices of many organisations changing. Community safety partners will continue to respond to the needs of the community and adapt their services and priorities as necessary,
- 3.2 Violence Against Women and Girls (VAWG) is an umbrella term used to cover a wide range of abuses against women and girls such as domestic homicide, domestic abuse, sexual assault etc. While men and boys also suffer from many of these forms of abuse, they disproportionately affect women. The Home Office has published a Strategy on Tackling Violence Against Women and Girls following several recent high-profile cases.
- 3.3 UK Strategies to Tackle Drugs and Crime: Since our last community Safety Agreement, the Home Office published the Beating Crime Plan 'Fewer victims, peaceful neighbourhoods, safe country.' The Government has invested in several programmes and funding schemes to help strengthen the ability to tackle these issues, including Safer Streets Fund, Violence Reduction Units, Supporting Families Fund, and tackling drugs supply and county lines.
- 3.4 In December 2021 the Government published 'From Harm to Hope' a 10-year drugs plan. The plan is the first Drugs Strategy which commits the whole Government along with public services to work together and share responsibility for creating a safer, healthier, and more productive society. The main aims are to break drug supply chains; deliver a world-class treatment and recovery system; and reduce the demand for drugs through changing attitudes in society.
- 3.5 War in Ukraine: The Russian invasion of Ukraine has so far led to at least 2.5 million people fleeing the country with EU officials predicting up to five million refugees. The UK alongside other countries across Europe and the rest of the world in terms of supporting the migration of refugees, Staffordshire has welcomed Ukrainian refugees fleeing the war. It is important to be aware of any changes in community tensions, such as protests or demonstrations and impacts on community relations.
- 3.6 Migration and Resettlement: At a national level, in 2021 the Government published a New Plan for Immigration (NPI) and Nationality and Boarders Act 2022. The UK currently runs a number of resettlement schemes and Staffordshire is a participant of these e.g., the Afghan resettlement scheme. Some migrants who arrive in the UK are 'unaccompanied asylum seeking children' (UASC) and as such are placed in the care of the local authority. There is a possibility of both pro and anti-migrant related tensions occurring in Staffordshire.

3.7 Protect Duty - The Protect Duty will require owners and operators of public spaces and venues to put in place measures to keep the public safe from a terrorist attack. The Draft Bill was published on 2 May 2023 and reflects lessons learned following the terrorist attacks and is known as Martyn's Law.

4 Governance

- 4.1 The Staffordshire Community Safety Partnership, known as the Safer and Stronger Communities Strategy Group (SSCSG) is responsible for the delivery of the Staffordshire Community Safety Agreement priorities, with membership taken from senior officers across the responsible authorities (see below), local Community Safety Partnership (CSP) Chairs the County Council portfolio holder together with non-statutory other agencies who contribute to the Partnership
- 4.2 The Responsible Authorities are: Staffordshire Police, Staffordshire District & Borough Councils, Staffordshire County Council, Staffordshire Fire & Rescue Service, NHS, and the Probation Service.
- 4.3 Partners aim to effectively and efficiently deliver the priorities outlined in this agreement and to comply with statutory responsibilities.

5. County Priorities

- 5.1 The priorities within this Community Safety Agreement have been identified using the findings of the Staffordshire Community Safety Strategic Assessment and the 8 District and Borough Strategic Assessments. These assessments drew upon data held by partners and included emerging issues with input from a wide range of stakeholders, including District Community Safety Partnerships. The Staffordshire Community Safety Strategic Assessment is attached as an appendix to this CSA.
- 5.2 The areas identified as Local Community Safety County Wide Priorities are as follows: -
 - Anti-Social Behaviour (ASB)
 - Community Cohesion & Tackling Extremism
 - Domestic Abuse
 - Drug Supply & County Line
 - Fraud
 - Serious Violence and Violence against Women and Girls
 - Safeguarding Vulnerable Persons (incl. Alcohol, Drugs and Mental Health) and Child Exploitation

- 5.3 The following areas identified in the strategic assessment affect some District/Borough Community Safety Partnerships significantly more than others. These will form part of the appropriate District/Borough partnership plans and as such will not be included in the county wide priorities.
 - Modern Slavery
 - Vehicle Crime
 - Rural Crime

6 Priorities by Locality

- 6.1 A considerable piece of work has been undertaken by the Knowledge Hub at Staffordshire Police in order to identify localities within Staffordshire & Stoke-on-Trent which would benefit the most from a strong partnership focus, in order to address long-standing challenges and vulnerabilities.
- 6.2 Areas have been identified through a combination of different elements of local area data (including crime, ASB and police intelligence and insight) covering multiple years, including prepandemic. Assessment of areas has considered levels of crime and disorder over time and the overall levels of vulnerability and risk in each area.
- 6.3 Due to levels of crime, disorder, vulnerability, and risk, some areas are considered a high priority at a force-wide level and are included below. Other areas experience challenges which are a priority for their local Safety Partnership area and will therefore be included in local District/Borough plans where appropriate.
- 6.4 Areas which are identified at a force-wide level as a priority reflect those selected by Staffordshire Police as in need of a 'Precision Policing' / Precision Community Safety approach. These are areas in the following Districts and Boroughs, East Staffordshire, Cannock, Stafford, and Newcastle-under-Lyme.

- 7.2 Where priorities already have existing partnership arrangements in place to facilitate and enable delivery, regular updates and assurances will be provided to the Safer and Stronger Communities Strategy Group via a named lead.
- 7.3 For clarification purposes, for priorities in 7.2, the Lead Officer named in the table below is the member of the Safer and Stronger Communities Strategy Group who provides the regular updates to the SSCSG meeting.
- 7.4 The themes coloured yellow in the table below indicate those priorities where the Safer and Stronger Communities Strategy Group will be responsible for monitoring performance against the delivery of the partnership priority.
