FINELLI PERSONAL LICENCE NUMBER IS PA/10/0016.

THERE WERE 4 DOOR STAFF PRESENT AT THE TIME OF THE CHECK, THESE WERE

ALL BADGES WERE DISPLAYED CLEARLY
AS THE HEAD DOOR PERSON, HE WAS ASKED BY MYSELF ON ARRIVAL TO GET THE DPS, HE REPLIED "WHAT FOR" I REPLIED "TO CARRY OUT A FULL LICENCING CHECK" HE THEN REPLIED "ARE YOU FUCKING JOKING IT'S THE BUSIEST NIGHT OF THE WEEK" HE SAID THIS AS HE WAS WALKING TO THE DOOR TO GET THE DPS.

THERE WERE 175 CUSTOMERS IN THE VENUE AT THE TIME OF THE CHECK THIS WAS CONFIRMED BY CLICKERS, THERE WERE 4 BAR STAFF WORKING ALONG WITH 1 GLASS COLLECTOR.
A SCOUT WAS OUTSIDE THE VENUE OFFERING 1 FREE SHOT WITH ANY DRINK.

THERE WERE 2 BREACHES FOUND AT THE TIME OF THE VISIT, IN CONTRAS TO ANNEX 2 SUB-SECTION 18 THERE WAS ONLY 1 SIGN ON DISPLAY WHICH WASN'T CLEAR, REQUESTING CUSTOMERS TO LEAVE THE VENUE QUIETLY. IN CONTRAS TO ANNEX 2 SUB-SECTION 21 THERE WAS ONE SIGN ON DISPLAY BY THE EXIT WHICH WASN'T VERY CLEAR REQUESTING CHILDREN TO BE SUPERVISED AT ALL TIMES.
